



MEMORANDUM OF UNDERSTANDING 2026 BETWEEN ESVS AND BNSAVS (Bulgarian National Society of Angiology, Vascular and Endovascular Surgery)

1. Parties

This Memorandum of Understanding (hereinafter referred to as “MOU”) is made and entered into by and between the ESVS and BNSAVS.

2. Purpose

The purpose of this MOU is to establish the terms and conditions under which the ESVS- BNSAVS membership agreement will function.

3. Term of MOU

This MOU is effective as of the date of the last signature below. The term of this MOU shall mirror the ESVS membership term. Regardless of the date of signature of this MOU, the membership benefits granted under the ESVS–BNSAVS agreement are activated and valid for a civil year, i.e. from 1 January to 31 December of the relevant year.

4. Responsibilities of ESVS

The ESVS will:

- Execute all membership activation in a timely manner.
- Provide membership support to the BNSAVS members via email or telephone.
- Treat members’ personal data in accordance with GDPR and the ESVS Privacy Policy, and its updates.

5. Responsibilities of BNSAVS

The BNSAVS will:

- The BNSAVS shall provide a list of BNSAVS members purchasing an ESVS Membership. This list must include all necessary information and be provided in English to ensure successful membership activation. A template will be provided by the ESVS. The list must include a minimum of ten (10) full members per membership year. There is no minimum requirement for trainee, senior, or medical student memberships.

- The BNSAVS may submit additional lists throughout the calendar year to include newly joining members. Each additional submission must include a minimum of five (5) new member activations, regardless of membership type. Specify accurate membership categories based on the ESVS membership criteria.
- Promote the ESVS Annual Meeting and other ESVS events on the BNSAVS website and through other communication means if possible.
- Comply with the European GDPR when sharing member data.
- Settle membership invoices within the next 30 days of receiving the invoice. The ESVS office will send reminders of pending invoices. If invoices remain unsettled within the next 30 days of this reminder, the ESVS will deactivate any accounts with pending payments.

6. General Provisions

A. Amendments.

Either party may request changes to this MOU. Any amendments shall be incorporated in writing, and effective when executed and signed by all parties.

B. Entirety of Agreement.

This MOU represents the entire and integrated agreement between the parties and supersedes all prior negotiations, representations and agreements, whether written or oral, relating to its subject matter.


C. Governing Law and Jurisdiction

This MOU shall be governed by and construed in accordance with the laws of France, without regard to its conflict of law rules. Any dispute arising out of or in connection with this MOU shall be subject to the exclusive jurisdiction of the courts of Bordeaux, France.

7. Signatures

The parties certify that they have read, understood, and agreed to the terms and conditions of this MOU as set forth herein.
